ILO & TIP 2010 GLOBAL REPORTS

- Adults/children in forced and bonded labour, slavery and forced prostitution around the world: **12.3 million**
- **Trafficked Persons of the 12.3 million was estimated to be 2.45 million**
- Successful trafficking prosecutions in 2009: **4,166**
- Successful prosecutions related to forced labour: **335**
- Victims identified: **49,105**
- **Ratio of victims identified to estimated victims: 0.4%**
- **Ratio of convicted offenders to victims identified: 8,5%**

ASSESSMENTS OF DANISH UNACCOMPANIED MINORS

- 2007: 24 assessments - 18 had further indicators.
- 2008: 26 assessments – 21 had further indicators.
- **2009: 44 assessments – 24 had further indicators.**
- **2010: 65 assessments – 47 had further indicators.**

IDENTIFIED VICTIMS IN DENMARK

- 2008: 4 children identified as VoT
- **2009: 5 children identified as VoT**
- **2010: 5 children identified as VoT**

TOTAL DANISH NUMBERS

1 AUG. 2007 – 30 SEP. 2010, TOTAL VoT NUMBERS OF MEN, WOMAN AND CHILDREN IN DENMARK:

- 127 VERIFIED VICTIMS OF TRAFFICKING
- **2 MEN**
- **2 CHILDREN**

ALL EXCEPT FOR ONE HAD CONNECTION TO THE SEXINDUSTRY.

TRIO ARRESTED FOR KNIFESTABBING IN UNDERPASS

TWO MEN AND A WOMAN GOT ARRESTED FOR STABBING A MAN IN BOTH LEGS, IN A UNDERPASS IN COPENHAGEN,

(POLICE CALL IT) A SUSPECTED DRUGRELATED CRIME.

Dancing thieves are targeting the night life.

DANCETHIEFS IS OFTEN FROM ALGERIA, MOROCCO OR TUNESIA AND MANY OF THEM HAS NOT BEEN HOME FOR MANY YEARS.

RED CROSS SECURITY LEVEL 3

- The child is followed with increased observation
- Round the clock staff.
- List of indicators for victims of trafficking is used for the observation of the child.
- Observations can result in decisions to implement security level 2 or 1.
- If indicators of human trafficking is observed, the municipality is informed for decisions of special actions or sanctions.
- In case of disappearance, the police is contacted according to the fixed procedure of all unaccompanied minor asylumseekers.

RED CROSS SECURITY LEVEL 2

- The child is closely followed and observed at the asylum center.
- Round the clock staff.
- Special procedures that describes the extent to which observations must be done so that the child is regularly checked for their presence at the center is followed.
- The child and youth commission of the municipality may decide to monitor the child's communication under the Social Services § 108 paragraph section 2.
- If the child does not show up at the external school, there is feedback to the center. If the child can not be located elsewhere the police is notified.
- A professional legal guardian is appointed to the child

In case of disappearance:

- police and the municipality is immediately informed.
- Picture, description and other information of the child is circulated to the local police departments and other departments where the child might disappear to.
- The Legal guardian and trafficking employee is informed as soon as possible.

RED CROSS SECURITY LEVEL 1

- The child and youth commission of the municipality may decide to monitor their child's communication under the Social Services § 108 paragraph section 2.
 - A special effort in terms of round the clock staff is assigned to the individual - funded by the migration office in order to ensure that the child does not disappear. This is done in cooperation with the municipality and if needed, the police.
 - It may be decided to accommodate the child to another address outside of the asylum center.
 - A professional legal guardian is quickly appointed to the child.
 - The Governmental anti-trafficking agency (CMM) is notified and the case is assessed in collaboration with them. They can offer their help in case of special needs, like having an specialized advocate assigned to the child.
 - The municipality and / - or representative is asked to give their consent to circulate picture and description of the child to other NGOs and local police in case of the child's disappearance.
 - The local police district and relevant partners are notified that the asylum center is accommodating a victim of trafficking, and to pay special attention if contact in case of the child's disappearance.
- In case of disappearance:
- police and municipality is immediately informed.
 - Picture, description and other information of the child is circulated to police departments and NGO's in areas where the child might disappear to.
 - The Legal guardian and trafficking employee is informed as soon as possible.
